
On November 21st, 2018, in the above-referenced matter, Midcontinent Communications (“Midco”) filed its Answer to the One-Call Complaint of Prairie View Excavating (“Prairie View”) with the Commission, and served a copy of its Answer via Certified U.S. Mail upon Prairie View Excavating Docket #3. However, to date, a return receipt has not been received indicating that Prairie View has received Midco’s Answer. Tracking information for this mailing is enclosed.
