The Coteau Properties Company has filed applications to renew and revise Surface Coal Mining Permit No. NACT-0201 covering lands located in:

**All or portions of Sections 2, 3, 4, 5, 6, 7, 8, and 9 of T144N, R88W; Sections 1 and 12 of T144N, R89W; Sections 30, 31, and 32 of T145N, R87W; and, Sections 3, 4, 9, 10, 11, 14, 15, 16, 21, 22, 23, 25, 26, 27, 28, 33, 34, 35, and 36 of T145N, R88W, Mercer County, North Dakota, containing 17,170.7 acres.**

The five-year permit renewal will allow Coteau to continue to operate within the existing permit area until April 14, 2024. The revision application identifies the next five-year coal removal areas. The revision also updates other information in the permit including introductory information, legal information, business entity/compliance information, identification of interests and rights of entry, geology, surface water hydrology, soil resources, general operations plans, surface water management, post-mining land use plans, revegetation procedures establishment and management, post-mining wetlands, post-mining stockponds and updates to the Consolidated Blasting Plan. 
