Dear Public Service Commission:

Please accept this letter as our formal complaint against Midwest Grain Trading and owner Hunter Hanson for non-payment of grain purchases from United Quality Cooperative (UQC) between September 2018 and November 2018.

Midwest Grain Trading, signer Hunter Hanson issued a not sufficient funds check to UQC dated October 26, 2018 for \$94,480.41. We have reversed the settlements associated with this check and included copies of all BOLs, contracts/trade confirmation, listing of unsettled shipments and a copy of the NSF check in this packet.

Our total loads picked up by Midwest Grain Trading and unpaid are:

- ❖ **Durum Bushels 34,323.09 = \$229,964.67**
- ❖ **Yellow Pea Bushels 17,2242.64 = \$117,975.08**

Please let us know as soon as possible if there is any more information required from us to file this formal complaint.
