In June 2018 there were 5 trade agreements written by East Central Grain Marketing Inc. United Quality Coop was listed as seller and Midwest Grain Trading was listed as buyer. The 5 trade agreements totaled 250,000 bushels of durum and 62,000 bushels of yellow peas for a total dollar amount of \$2,101,260.00

Hunter Hanson would not complete our credit agreement so there was a verbal agreement that he would pay us every Friday and no more than 5 loads could be picked up before we would receive payment. We received check #1603 dated 9/21/2018 \$36,272.28 and check# 1633 dated 10/02/2018 \$38,598.93 and they both cleared the bank. The 3rd check was lost in the mail and the 4th check #1749 dated 10/26/18 \$94,480.41 was returned non-sufficient funds.
