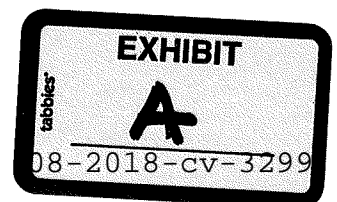

**ORDER APPOINTING
TRUSTEE**

[¶] 1] The Public Service Commission has moved the Court for appointment as Trustee of Hunter Hanson d/b/a NoDak Grain, under North Dakota Century Code chapter 60-04. Hunter Hanson d/b/a NoDak Grain, license address of 2373 65 1/2 St. NE, Rugby, ND 58368, operates licensed grain warehouses at Tunbridge and Rohrville, North Dakota, under North Dakota Century Code chapters 60-02 and 60-04.




[¶ 2] It appears from the record that Hunter Hanson d/b/a NoDak Grain is insolvent under North Dakota Century Code chapter 60-04 as of a date on or before November 14, 2018, and that it is in the best interest of potential claimants and the parties to this proceeding that a trustee be appointed.

ORDER

[¶ 3] **THEREFORE, IT IS ORDERED** on the Application and Motion of the Public Service Commission by and through its attorney, the Public Service Commission is appointed trustee of the trust fund provided by North Dakota Century Code chapter 60-04 for the purpose of marshalling all trust assets of the insolvent Hunter Hanson d/b/a NoDak Grain, in the manner provided by law.

[¶ 4] **IT IS FURTHER ORDERED** that the date of insolvency be established as on or before November 14, 2018.
