1. I am a citizen of the United States of America, of legal age, residing in Mandan, North Dakota.

I am the Director of the Compliance Division for the Public Service Commission (Commission) and as such, am charged with the duty of enforcing the provisions of North Dakota Century Code chapters 60-02, 60-02.1 and 60-04 for purposes of this insolvency. The Compliance Division was responsible for the licensing of public grain warehouses and roving grain buyers in North Dakota prior to July 1, 2019.


