1. I am an attorney duly licensed to practice law in the State of North Dakota, and am admitted to practice before this Court.



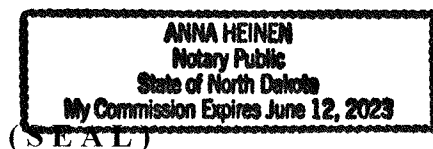


