5. Attached hereto as an updated Exhibit L is a true and correct copy of the most recent bank account statement for the Midwest Grain Trading Trust Fund.


6. Attached hereto as an updated Exhibit 46, which is a final summary related to Co-op Elevator of McClusky's claim.
