Response to Item 15b - 10- Year Spill History

ONEOK provides the following table in response to the request for additional records of pipeline releases dating back 10 years. ONEOK's North Dakota operations were merged into the company through a transaction that was completed in 2006. From 2006 through 2011, ONEOK's North Dakota operations were substantially less than what it presently owns and operates and were limited to two (2) natural gas processing plants and associated gathering systems, and one (1) natural gas liquids pipeline. Accordingly, the enclosed table includes a list of all pipeline releases of over one (1) barrel of liquids in the state of North Dakota that ONEOK has confirmed back to 2009.
