NOTICE OF RECEIPT OF REVISION APPLICATION

August 26, 2020

Dakota Westmoreland Corporation has filed an application for Revision No. 32 to Surface Coal Mining Permit No. KRSB-8603 at the Beulah Mine. This revision application proposes to modify the post-mine topography in the Gold Pit area in Sections 15, 21, 22, and 23 of T143N, R88W and revises the reclamation schedule for the Gold, Silver and Iron Pits. The revision also updates the permit in response to a midterm review. Revision 32 updates the business entity and compliance information, surface and coal ownership, ground water monitoring plans, surface water management plans, mining and reclamation plans and the estimated worst-case reclamation cost.

Due to the COVID-19 pandemic, a copy of Dakota Westmoreland Corporation's Revision 32 application will not be available for inspection at the Public Service Commission, State Capitol, Bismarck, ND, or the Mercer County Auditor's office. You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on landowners in the permit area. You may request an informal conference with the Commission and the applicant on the application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, petitions, or requests for an informal conference must be filed with the Commission by October 12, 2020.

If there is an informal conference, you may request a formal administrative hearing on the Commission's ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
