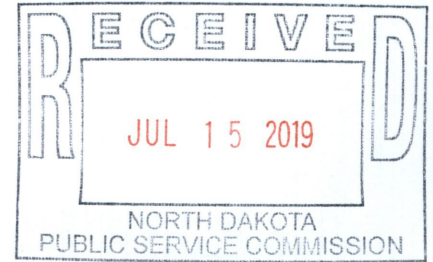

**ORDER GRANTING REQUEST FOR EXTENSION**

**OAH FILE Nos. 20190068 and 20190068**

A public hearing was held on Ruso Wind Partners, LLC's ("Ruso Wind") applications in the above referenced cases on June 17, 2019. At the conclusion of the hearing, the record was left open until July 12, 2019 for receipt of late-filed exhibits (pre-marked as Exhibits #52-57) and proposed Findings of Fact, Conclusions of Law, and Order. One of the anticipated late-filed exhibits is an update of Ruso Wind's conversations with the Minot Air Force Base regarding a letter from the Department of Defense dated June 6, 2019. This exhibit has been assigned Exhibit #51.

On July 11, 2019, Ruso Wind file a written request to extend the deadline for filing the late-filed exhibits and proposed Findings of Fact, Conclusions of Law, and Order to August 9, 2019. To date, Ruso Wind has been unable to speak with representatives at the Minot Air Force Base.

There is no objection to Ruso Wind's request for an extension.

It is **HEREBY ORDERED**, the deadline to file late filed Exhibits #52-57 and Proposed Findings of Fact, Conclusions of Law, and Order is extended to August 9, 2019.


