Good Morning Holly, Deedra, and Keith,

I have attached copies of the Intrastate TRP, Post True-up Access Recovery Charge (ARC) report, USAC Report with the Post True-up CAF ICC amount, the associated certifications that were submitted to NECA, as well as the Local Rate Floor Data Certification. NECA will be filing the CAF-ICC information with the FCC and USAC. The ARC rates that are attached will be effective in July 2019.




