John Staurulakis, Inc. ("JSI") files the enclosed Price List on behalf of Inter-Community Telephone Co. ("ICTC"). The Price List includes currently effective rates for flat rate residence basic telephone service essential services as defined in NDCC § 49-21-01. ICTC proposes to equalize among all exchanges flat rate business local exchange rates, and to introduce optional flat rate extended area service ("EAS") effective February 14, 2019. This filing is submitted on at least twenty days' notice pursuant to NDCC § 49-21-04. An original and six (6) copies are provided as well as an electronic copy via email.

The introduction of EAS and the associated monthly recurring charge will afford all ICTC customers the option of one-way local calling to the Valley City, North Dakota exchange from all ICTC exchanges. Customers will benefit from the elimination of toll calls to Valley City.
