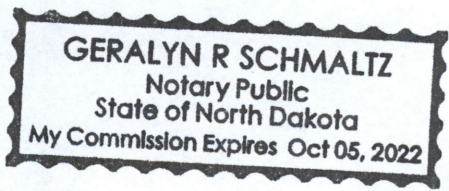

**ORDER SUSPENDING WAREHOUSE LICENSE
AND NOTICE OF OPPORTUNITY TO BE HEARD**

February 28, 2019

Arthur Glasoe & Lance Glasoe dba Wildrose C & D operates a licensed public grain warehouse at Wildrose, North Dakota, under license no. 891 issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On January 7, 2019, the Commission received notice that the Certificate of Insurance on Grain issued to Arthur Glasoe & Lance Glasoe dba Wildrose C & D will be cancelled. The effective date of cancellation is March 9, 2019. North Dakota Century Code section 60-02-35.1 provides the Commission shall immediately suspend the warehouseman's license if the licensee fails to file a replacement insurance certificate at least thirty days before cancellation of the current insurance filing. As of February 8, 2019, no replacement insurance had been filed with the Commission.

Order

The Commission orders that warehouse license number 891 issued to Arthur Glasoe & Lance Glasoe dba Wildrose C & D is suspended effective February 8, 2019. The licensee shall:

1. Within five days of receipt of notice, notify each receipt holder with written notice that its warehouse license is suspended and that grain must be removed from the warehouse or it will be priced and redeemed in cash in accordance with North Dakota Century Code section 60-02-41.
2. Keep the Commission's suspension notice conspicuously posted in the office window or on the front driveway door of the elevator.
3. Surrender warehouse license no. 891 to the Commission.

4. Not receive additional grain for purchase, storage, shipping or processing.
5. Not sell or ship any grain without submitting a written request to the Commission and receiving Commission authorization to do so.

Notice

PLEASE TAKE NOTICE that Arthur Glasoe & Lance Glasoe dba Wildrose C & D has until March 8, 2019, to procure and file adequate insurance or submit a written request for hearing.

North Dakota Century Code section 60-02-10.1 provides:

The commission may suspend or revoke the license of any warehouseman for cause upon notice and hearing. Notwithstanding any other provisions of this chapter, the license of a warehouseman must automatically be suspended for failure at any time to have or to maintain either a bond or insurance policy in the amount and type required. . . .
