

BUDGET NARRATIVE

The Public Service Commission (PSC) is requesting all federal funds that have been allocated to North Dakota for its approved Abandoned Mine Lands (AML) Reclamation Program for Federal Fiscal Year 2019. The following is the breakdown of funds that have been allocated to North Dakota and reflects the 6.2% reduction due to sequestration:

The requested funds will be used for the administrative costs associated with the program and for construction costs to reclaim abandoned surface and underground coal mines in North Dakota.

ADMINISTRATIVE NARRATIVE

I. PERSONNEL

The PSC will use 2.0 full-time equivalents (FTE) to administer the approved AML Reclamation Program for the 12-month administrative grant period. Time that a PSC attorney will devote to legal work associated with the AML program will be part of the indirect charges to the grant. Table 1 lists the annual salary amount for these positions during the first year of the grant. The amount budgeted for the fringe benefits is shown below. Total direct salaries for the administrative grant are budgeted at \$164,348.

II. FRINGE BENEFITS

The estimated fringe benefit costs for 2.0 positions for the 12-month administration period are \$70,670. Included under fringe benefits are: health insurance, contributions to the state public employee retirement plan, FICA, unemployment insurance, and workers compensation. The fringe benefit rate averages 43 percent of the direct salaries.

III. TRAVEL

The AML Division estimates \$12,500 in travel expenditures for the administrative portion of the grant. These anticipated expenditures include staff travel to NAAML and IMCC meetings, other conferences, and in-state travel to AML sites by management staff.

The budget for meals and lodging costs is \$5,500. The State of North Dakota has established travel policies for meal and lodging reimbursement. In-state rates for meals are \$35 per day and about \$84.60 plus applicable tax per night for lodging. Out-of-state rates for meals are based on federal rates and lodging at actual cost.

Anticipated air transportation costs of \$5,000 are budgeted for trips to NAAML and IMCC meetings, other conferences and training seminars.

Motor pool costs for the administrative grant year are estimated at \$2,000, primarily for in-state travel to AML sites by management staff. The AML Division normally uses vehicles owned by State Fleet Services. The PSC pays a monthly charge based on type of vehicle plus a mileage rate that covers the operating costs. The monthly charge covers the cost of depreciation. The operating costs include fuel, repair parts, insurance, licenses, direct labor, and shop overhead. Vehicle replacement charges imposed by State Fleet Services are not charged against the grant and are paid for with state general funds. In case a privately owned vehicle is approved for use to conduct state business, the mileage reimbursement rate cannot exceed that set by state law.

IV. EQUIPMENT

The Federal Assistance Manual's definition of equipment is tangible, personal property having a useful life of more than one year and an acquisition cost of \$5,000 or more per unit. No equipment purchases of more than \$5,000 per unit are anticipated during the administrative grant year.

V. SUPPLIES

The Abandoned Mine Lands Division has estimated \$12,250 for the budget category "Supplies."

Reproduction/Printing costs are estimated at \$1,000, expenditures include: printing of bid documents, maps and plats, contract reporting forms, and other materials related to the AML program.

Office supplies are estimated at \$750 and another \$1,000 is budgeted for office equipment.

Miscellaneous supplies are budgeted at \$1,500 during this grant period and include books, periodicals, technical subscriptions, hard hats, safety boots and uniform shirts.

The amount allocated toward Specialized Technical and GIS Software is \$3,500 and that will be used for specialized software that may be needed to support the ongoing development of a GIS and other needs specific to the AML program.

Expenditures of \$4,500 are anticipated for purchases of images for use in the GIS, engineering supplies, tool kits, stakes, ribbons, spray paint, etc.

VI. OTHER

The AML Division has estimated \$66,500 for the budget category "Other."

The cost of office rent in the Capitol for AML staff is estimated at \$15,000.

AML staff will be given the opportunity to participate in technical conferences and training seminars relative to each individual staff person's expertise. Registration and tuition costs for these conferences and seminars are estimated at \$4,000 for this grant period.

Equipment rental is \$1,000, which includes equipment rental by the AML Division, such as metal detectors to find previously cased holes.

Also included are operating fees and services on the amount of \$14,000 for abstracting, advertising, water and soil sample analyses, and other costs.

Professional and legal services of \$16,000 are budgeted for any outside legal and/or professional services for title opinions and any disputes involving the construction projects.

Central service costs charged by the State Office of Management and Budget and the cost of the next federal financial and compliance audit of North Dakota's AML program grants is estimated at \$5,000. The State Auditor's Office will perform any audits.

Dues for the National Association of AML Programs and the AML Division's share of North Dakota's membership in the Interstate Mining Compact Commission are approximately \$9,000.

The estimated cost of miscellaneous repairs is \$2,500 and this is also included in the "Other" category.

The PSC has moved IT services and equipment, copier charges, and landline and cellular telephone services to general office expenses. These costs are part of the indirect cost rate so no direct charges are made for these items.

VII. TOTAL DIRECT COSTS

Total direct costs are \$326,268 for this grant period.

VIII. INDIRECT COSTS

The approved indirect cost rate for North Dakota's 2017-2019 biennium is 33.41%. The proposed indirect cost rate for North Dakota's 2019-2021 biennium is 31.75%. Total indirect costs for the administrative grant are estimated at \$75,919.

VIX. TOTAL COSTS

The total estimated budget for the 2019 AML North Dakota Reclamation Program Administrative Grant is \$402,186.

X. PROGRAM INCOME

No program income is expected during the grant period since the AML Division no longer charges potential bidders for copies of the bid plans and specifications. Most potential bidders are now able to view and download the project plans and specifications from the State Procurement Office's website.

BUDGET NARRATIVE - CONSTRUCTION

I. PERSONNEL and FRINGE BENEFITS

The PSC will use 2.5 full-time equivalents (FTE), plus up to three seasonal construction inspectors, for construction projects during the 36-month grant period. Table 2 lists the annual salary amount and fringe benefit rates for these positions during the first year of the grant. The fringe benefit rate for permanent full time employees averages 43 percent of the direct salaries and the fringe benefit rate for the seasonal construction inspectors is 43 percent. Total salaries for the construction project staff during the one-year period are estimated at \$287,527 and fringe benefits are \$123,637. The indirect costs that are calculated on the total amount of salaries and fringe benefits are estimated at \$132,820.

II. TRAVEL

The AML Division estimates approximately \$65,000 in travel expenses for construction projects. These anticipated expenditures are for staff travel to project sites during construction activities.

The budget for meals and lodging costs is \$25,000. The State of North Dakota has established travel policies. In-state rates for meals are currently \$35 per day and about \$84.60 plus applicable tax per night for lodging. State motor pool expenses are estimated at \$40,000 for project related work.

III. CONSTRUCTION PROJECTS

The AML Division is budgeting \$1,677,831 from the 2019-22 grant for construction projects at abandoned coal mines during the grant period. The following major projects are proposed for reclamation during the 2019 construction season:

2019 Williams County Road 9 Phase 7 and Noonan AML Project: This remote backfilling project will stabilize underground coal mine workings at an industrial development near Williston and along Divide County Highway 21 and other roads and trails south of Noonan. This project includes drilling into the mine workings, casing drill holes where voids are found, pumping cementitious grout and foamed sand. Material testing will be conducted in a separate contract. It is estimated that 3,500 cubic yards of grout and 1,000 tons of foamed sand will be pumped into mine voids and about 15,000 feet of drilling will be needed. The estimated project cost, including grout testing, is \$1,081,475.

2019 Exploratory Drilling AML Project: This investigatory project will be conducted to locate and characterize suspected abandoned underground coal mines at an industrial subdivision near Williston, North Dakota. This project includes drilling into the mine workings and casing drill holes where voids are found for future grouting. It is estimated that 40,000 feet of drilling will be needed. The estimated project cost is \$366,890.

2019 Morton County Phase 2 AML Project: This 30-acre project will reclaim five surface mines and eliminate about 4,400 feet of dangerous highwalls in Morton County. These AML sites are characterized by steep final pit highwalls that are about 15-40 feet high. The proposed reclamation work primarily involves backfilling the highwalls with earthen material from adjacent spoil piles. About 150,000 cubic yards of spoil material will need to be moved in the reclamation process. The estimated project cost is \$332,000.

2019-2020 Sinkhole Filling AML Project: This two-year project will be conducted to fill dangerous sinkholes caused by underground mine collapse. Some funds may be used to conduct maintenance work on reclaimed sites. If necessary, some of these funds may also be used for emergency projects. The estimated 2019 project cost is \$100,000.

The total estimated project contract costs for 2019 are \$1,880,365. It appears about \$1,700,000 will remain in North Dakota's 2018-2021 AML grant. The remaining funds in the 2018-2021 grant will be used to pay a portion of the contract costs incurred during the 2019 construction season. Any funds from the 2019-2022 construction grant that are not used in 2019 will be used similarly during the 2020 construction season.

5. Program Narrative

The 2019-2022 AML grant will be used to eliminate hazards associated with abandoned surface and underground coal mines located in western North Dakota. The AML Division estimates approximately \$2 million will be spent for construction projects at abandoned coal mines in 2019. Some grant funds will be used for the in-house design of reclamation projects and for administering the program. Construction funding will come from the 2019-2022 grant and funds remaining from the 2018-2021 grant, about \$1.7 million. The following projects are proposed for the 2019 construction season.

2019 Williams County Road 9 Phase 7 and Noonan AML Project: This remote backfilling project will stabilize underground coal mine workings at an industrial development near Williston and along Divide County Highway 21 and other roads and trails south of Noonan. This project includes drilling into the mine workings, casing drill holes where voids are found, pumping cementitious grout and foamed sand. Material testing will be conducted in a separate contract. It is estimated that 3,500 cubic yards of grout and 1,000 tons of foamed sand will be pumped into mine voids and about 15,000 feet of drilling will be needed. The estimated project cost, including grout testing, is \$1,081,475.

2019 Exploratory Drilling AML Project: This investigatory project will be conducted to locate and characterize suspected abandoned underground coal mines at an industrial subdivision near Williston, North Dakota. This project includes drilling into the mine workings and casing drill holes where voids are found for future grouting. It is estimated that 40,000 feet of drilling will be needed. 2019-2020 Sinkhole Filling AML Project: This two-year project will be conducted to fill dangerous sinkholes caused by underground mine collapse. Some funds may be used to conduct maintenance work on reclaimed sites. If necessary, some of these funds may also be used for emergency projects. The estimated 2019 project cost is \$100,000.

2019 ADMINISTRATIVE AND CONSTRUCTION ACTIVITIES - OBJECTIVES AND NEED FOR THIS ASSISTANCE

This Grant will fund the administration and implementation of the approved North Dakota Abandoned Mine Lands Reclamation Program from March 1, 2019 to February 28, 2022.

The objectives for this grant are:

- Fund project design and engineering, NEPA compliance, cultural resources (Section 106 Compliance), and site monitoring;
- Keep the “Standard Specifications for AML Reclamation Projects” current;
- Cover any amendments to our State Program that might be warranted;
- Continue to add available data on all abandoned coal mines not yet on file into our inventory;
- Be a repository for information regarding abandoned mines;
- Investigate and design all new coal-related AML projects;
- Fund salaries for North Dakota AML personnel;
- Perform necessary travel to conduct state business, meet with OSMRE personnel, attend national conferences and meetings related to abandoned mine land reclamation;
- Fund travel for construction site inspections and site investigations;
- Obtain equipment necessary to efficiently implement the State AML Program;
- Continue to update position descriptions for each employee;
- Conduct staff performance appraisals once every twelve months;
- Fund professional and legal services such as property abstracting and title opinions
- Prepare requests for authorization to proceed and eligibility determinations for AML sites;
- Contract for construction services on eligible and approved abandoned mine land sites; and,
- Continue development of the Geographic Information System (GIS) for AML sites and projects.

RESULTS OR BENEFITS EXPECTED FROM THESE OBJECTIVES

The North Dakota Public Service Commission AML Division, by operating under these objectives, will fulfill obligations to abate present hazards to public health, safety and general welfare and to the environment that presently exist because of abandoned mines in North Dakota. The AML Division will provide necessary reclamation planning specific to North Dakota's needs. All North Dakotans will benefit from this assistance by providing a safer and cleaner environment for everyone's enjoyment. The economy will benefit from jobs created through expenditures under this program. Documentation of available information for AML sites will benefit the public at large.

APPROACH

- a. The North Dakota AML Program, administered by the North Dakota Public Service Commission, will use staff expertise to identify, monitor, propose and design reclamation projects. Reclamation construction will be engaged through contracts with construction contractors who are qualified to complete approved coal reclamation and maintenance construction projects. The administration of these projects will be borne by this Consolidated Grant. The AML Division will perform or contract for services to carry out the following work:
 - Cultural resource evaluations and NEPA compliance;
 - Title searches, landowner right-of-entry acquisition, and eligibility determinations; and,
 - Development of construction design and specifications for individual project sites.
- b. The fieldwork for the following studies may be undertaken during the 2019 field season:
 - Cultural resource surveys;
 - Ground water and surface water monitoring;
 - Laboratory work, including analysis of soil, water and grout mix samples before, during and after reclamation; and,
 - Aerial photogrammetry.
- c. Data to be collected:
 - Cultural, historical and archeological resources;
 - Environmental assessment, investigation and analysis;
 - Ground and surface water analysis;
 - Soil/grout mix testing;
 - Surface ownership documents; and,
 - Aerial photogrammetric surveys, including development of topographic maps.

- d. Experienced and competent firms will be awarded contracts for the following work:
- Any cultural and historic resource survey work that is needed;
 - Aerial photogrammetry;
 - Title evaluations; and,
 - Construction services on approved abandoned mine sites.

Firms will be chosen according to established state procurement procedures. Firms selected will be awarded contracts funded by this Consolidation Grant.

GEOGRAPHIC LOCATION

The North Dakota Public Service Commission has its offices located in the State Capitol in Bismarck and the AML reclamation will occur at abandoned coal mines in the western part of North Dakota.






