The public will have access to the meeting via our online live stream and are invited to submit written comments.

Please limit the number of individuals from your agency who attend the meeting in person. If you or anyone who will be presenting does not have security card access to the Capitol, please let me know and we will provide the presenter's name to the Capitol security personnel as public access is limited to those with an appointment. If the restrictions on public access to the Capitol are lifted before June 9, you can enter the Capitol as you normally would. Please note due to the renovation of the Capitol's south entrance, all visitors are required to enter through the west entrance.

Because the committee members will be participating by teleconference, they will be accessing your testimony electronically. Please email me your testimony no later than June 7 so we can link your testimony to the agenda for the committee members and the public. Also, for those following along with your testimony remotely, please include page numbers on your documents.

As I mentioned, the meeting will be streamed live at <http://video.legis.nd.gov/>, however, we have asked the committee members NOT to watch/listen to this livestream during the meeting due to a 20-30 second delay from the real-time teleconference.
