Dear Raymond L. and Zonia D. Wilson:

In association with the Line 3 Replacement Project, Enbridge Energy, Limited Partnership, a Delaware limited partnership is proposing to install a pipeline (hereinafter referred to as the "Facilities") within five hundred (500) feet of an inhabited residence located on your property described below:

All that part of the Northwest Quarter of the Northeast Quarter (NW¼NE¼) of Section 15, Township 161 North, Range 51 West of the 5th P.M., further described as follows: Commencing at the Northeast corner of said Section 15; thence on an assumed bearing of North 90°00'00" West along the north line of said Section 15, a distance of 1983.98 feet; thence South 24°55'56" East a distance of 490.00 feet to the point of beginning; thence continuing South 24°55'56" East a distance of 310.00 feet; thence North 90°00'00" West a distance of 550.00 feet the east right-of-way line of State Highway No. 44; thence North 24°55'56" West along said right-of-way line a distance of 170.00 feet; thence North 75°30'11" East a distance of 507.13 feet to the point of beginning. Parcel contains 2.750 acres, more or less, Pembina County, North Dakota. (the "Property").

Under North Dakota law (North Dakota Century Code § 49-22.1-05 and North Dakota Administrative Code § 69-06-08-02(2)), the area within five hundred (500) feet of an inhabited residence is an "avoidance area" that shall not be considered by the North Dakota Public Service Commission in the routing of a pipeline unless there is no reasonable alternative or the landowner grants a written waiver of the avoidance area requirement.

By signing this letter where indicated below, you, as owner of the inhabited residence on the Property, acknowledge that you do not object to the placement, or the future operation and maintenance, of the Facilities within five hundred (500) feet of said inhabited residence.





4. In regards to financial matters, Lutheran Social Service of Minnesota shall have authority to be listed as Representative Payee with the U.S. Social Security Administration. Lutheran Social Service of Minnesota shall further have full authority over any and all cash assets, bank accounts, investment accounts, retirement accounts, and insurance policies. Lutheran Social Service of Minnesota shall also take control and have authority over the Ward's house located at 15968 94th Street NE, Drayton, ND and any and all real estate owned by the Ward.

5. In regards to farm equipment, Ronald Wilson shall have a limited conservatorship over all farm machinery. Ronald Wilson will file an initial inventory list of farm machinery owned by Raymond and Zonia Wilson within ninety (90) days, and will file an annual report by December 31st of each year. Ronald Wilson is authorized to use said equipment without cost. The ward's farm machinery cannot be sold or traded without Court approval. Court approval can be obtained by filing a written petition with the Court with a copy of any petition served on the appropriate parties.

6. Guardian is further permitted to have law enforcement in the state assist the Guardians with locating and returning the ward to his place of residence should he leave the premises without Guardian's approval.

7. In granting or withholding consent for decisions, the Guardian and Conservator shall be bound to ascertain to the extent possible the ward's wishes, and to abide by them where the wishes appear to be consistent with the ward's best interests.

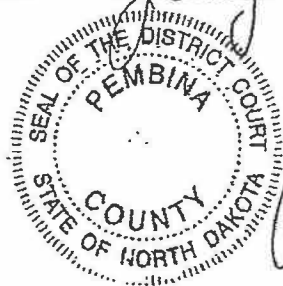
