Dear Mr. Kahl:

As you know, in accordance with the provisions of Section 49-22-16 of the North Dakota Century Code, when an application for a certificate for a gas or liquid transmission line is filed, the Commission must notify the townships with retained zoning authority, cities and counties in which any part of the proposed corridor is located.

Township 132 North Range 77 West, the location of the proposed pump station, is not an organized township. The proposed pump station is 5 miles from the City of Linton and the corridor for Dakota Access does not include the City of Linton.
