APPLICATION FOR TRADE SECRET PROTECTION

COMES NOW, Inter-Community Telephone Company, LLC (“ICTC”) and respectfully moves the Commission for entry of a trade secret protective order under § 69-02-09-01 of the North Dakota Administrative Code. The purpose of the requested protective order is to protect against public disclosure of trade secret information as defined by NDCC § 47-25.1-01.

1. A general description of the nature of the information sought to be protected.

ICTC wishes to protect from disclosure financial information contained in the attached sealed Financial Statement. (Attachment 1.)

2. Explanation of why the information derives independent economic value,

The financial information could have economic value to potential competitors, and in a competitive telecommunications marketplace, this type of information is highly sensitive and its public disclosure could place ICTC at a competitive disadvantage.

3. An explanation of why the information is not readily ascertainable by proper means by other persons.

The confidentiality of financial information has been maintained by the ICTC and is not readily available by proper means to competitors or to the general public.

- 6. A description of the efforts used to maintain the secrecy of the information.**


