1. My name is Steve Monilaws and I am President of Absaraka Cooperative Telephone Co., Inc. ("Absaraka").
2. I submit this affidavit in support of the above-referenced joint applications. Upon Commission approval, Absaraka will transfer its Certificate of Public Convenience and Necessity Number 5769, of Case No. PU-13-247 for the Absaraka exchange to ICTC. Absaraka further requests transfer of its ETC study area, designated in Case No. PU-405-97-549, to ICTC.
3. Absaraka intends to assign the relinquished the Absaraka exchange to Inter-Community Telephone Company, LLC ("ICTC"). Absaraka will continue to provide local service until all members in the Absaraka exchange have been connected to ICTC.
4. Absaraka has contacted all Absaraka local exchange members and received consent for the proposed assignment to ICTC. See attached. Absaraka exchange members would like to connect to ICTC to gain access to higher speed internet services, access to ICTC TV programming and access to ICTC's local calling area.

In consideration of the foregoing, Absaraka hereby requests the Commission grant its request for transfer of CPCN for the Absaraka exchange, and its designated ETC study area to ICTC.

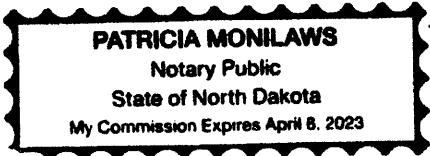
