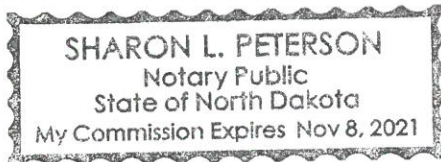

Public input received by the Commission will be placed into the record for consideration. The Commission will receive testimony through the following methods:

• Telephonic - The public may provide input over the phone by calling 701-328-4081 to be placed on a list. On May 22, 2020, the Commission will call you back to receive your input at the end of the hearing in an order determined by the Administrative Law Judge. On August 30, 2019, Northern States Power Company filed an application for an Advance Determination of Prudence to acquire, own and operate the 98.9 MW repowered Mower County Wind Energy Facility located at Grand Meadow, Mower County, Minnesota. The Mower County wind facility consists of 43 2.3 MW turbine generators. The issues to be determined in this matter are:
1. Whether NSP's proposed resource addition is prudent; and
2. Whether the Commission should grant NSP an advance determination of prudence.
