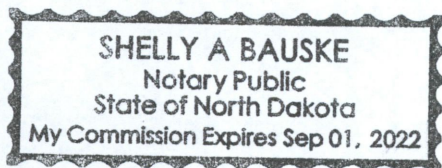


NOTICE OF OPPORTUNITY FOR HEARING

October 22, 2019

On February 6, 2019, in Case No. PU-18-281 the Commission adopted Findings of Fact, Conclusions of Law and Order issuing Route Permit Number 218 and Certificate of Corridor Compatibility Number 208 to Emmons-Logan Wind, LLC for the construction and operation of approximately 6.85 miles of 230 kV electric transmission line and associated facilities in Emmons County, North Dakota.

On October 3, 2019, in Case No. PU-19-333, Emmons-Logan Wind, LLC and Emmons-Logan Interconnection, LLC filed a Joint Application for Expedited Transfer of Route Permit Number 218 and Certificate of Corridor Compatibility Number 208, from Emmons-Logan Wind, LLC to Emmons-Logan Interconnection, LLC.

The issues to be considered in Case No. PU-19-333 are whether Emmons-Logan Interconnect, LLC agrees and is able to comply with the terms and conditions of Route Permit Number 218 and Certificate of Corridor Compatibility Number 208, and whether the requested transfer is compatible with the public interest.


Those interested are invited to comment on the application in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and reasons for requesting a hearing. **Comments and requests for hearing must be received by November 22, 2019.** If deemed appropriate, the Commission can determine the matter without a hearing.
