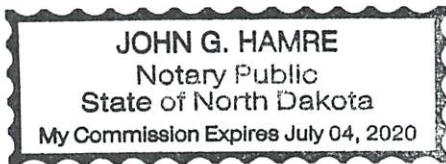

CORRECTED NOTICE OF OPPORTUNITY FOR HEARING

December 18, 2019

On **October 14, 2019**, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Justin & Allen Zerr (Zerr Family Farm) at a location in Wells County, ND.

Submitted with the application was a statement by Justin & Allen Zerr (Zerr Family Farm) that they desire electric service to be provided by the applicant. Service is to be provided at a point located in:

**The NW/SW 1/4 of Section 21, Twp 150N, R 72W, Wells County,
North Dakota**

It was discovered that the legal description of the point of service was incorrect on the application that Otter Tail Power had originally submitted.

On **November 26, 2019**, Otter Tail Power Company submitted a statement with the corrected legal description. The corrected legal description of the point of service is:

**The NW 1/4 of the NE 1/4 of Section 21, Twp 150N, R 72W, Wells County,
North Dakota**

Otter Tail Power Company has made a prima facie showing that it should serve the customer.

Any interested party has the right to file written objection, based on the issue of public convenience and necessity, with the Commission by **January 13, 2020** and the matter will then be set for hearing. If no objections are received by that date, the application may be granted as requested.
