

Dear Mr. Kahl:

On April 22, 2020, ONEOK Bakken Pipeline, L.L.C. ("ONEOK") provided an update to the Commission regarding the status of remaining 500-foot landowner setback waivers indicating that three waivers remained outstanding. *See*, Docket No. 87. However, as a result of the route modification detailed in ONEOK's May 5, 2020 certification filing, a waiver is no longer required for the occupied structure located at approximate milepost 16.3. *See*, Docket No. 96. Of the two remaining setback waivers, ONEOK has acquired a landowner waiver for the occupied structure located at approximate milepost 12.0, as identified on map page 3 of 13 located in Exhibit B.2 of the Application (Docket No. 1). A copy of this setback waiver is enclosed for filing.
