Dear Mr. Nitschke:

John Staurulakis, Inc. ("JSI") files the enclosed Price List on behalf of Inter-Community Telephone Company ("ICTC"). The Price List serves to add Absaraka, exchange (896), to the list of currently effective rates for flat rate residential and business basic telephone essential services as defined in NDCC § 49-21-01. The Absaraka exchange is being added as a result of the Absaraka Co-operative Telephone Co. Inc. being condensed into the Inter-Community Telephone Company through an asset purchase.

The Absaraka exchange local service rates for residential service will increase from \$18.00 to \$22.50; business local service rates will increase from \$18.00 to \$31.50; extended area service ("EAS") will be added at the rate of \$0.95, consistent with all other ICTC exchanges, and as defined on 1st Revised Sheet 1 of this filing. A notice of information was sent to all Absaraka Co-operative Telephone Co. Inc. customers December 2, 2019 advising of billing and rate changes effective January 1, 2020.

The On-Premise Extension Service, which currently has no subscribers, is being deleted from the price list.

This filing is submitted with at least twenty days' notice pursuant to NDCC § 49-21-04. An original and six (6) copies are provided as well as an electronic copy via email.
