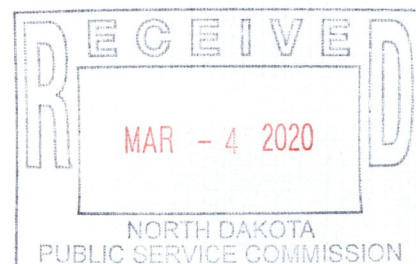

A consolidated public hearing regarding the above referenced applications has been scheduled for 9:30 a.m. on April 17, 2020 at the Memorial Hall in Bowbells, North Dakota. A telephonic prehearing conference was held on March 2, 2020. Special Assistant Attorney General Brian Schmidt appeared on behalf of the Public Service Commission. Attorney Casey Furey appeared on behalf of Northern Divide Wind, LLC. Also appearing at the hearing on behalf of the applicant were Tracy Davis, Clay Cameron, and Dustin Jones.

The parties agreed to a deadline of April 1, 2020 for the submission of pre-filed testimony and proposed exhibit lists. Northern Divide Wind, LLC intends to have a court reporter at the hearing. In order to make the transcript more accessible, the parties agreed that anyone wishing to provide public testimony at the hearing should provide his or her name, spell it, and provide his or her residential address and the address of any other property owned and affected by the application. If the public commenter knows the township where the property lies, that information will be requested as well. The undersigned Administrative Law Judge agreed to solicit this information from the public commenters.
