**NOTICE OF RECEIPT OF REVISION APPLICATION**

**April 15, 2020**

The Falkirk Mining Company has filed an application for Revision No. 40 to Surface Coal Mining Permit No. NAFK-8405 for the Falkirk Mine. This revision proposes to modify the post-mining topography for a large portion of the unmined areas within the permit. Sections of the permit revised or updated with this revision include introductory, legal, financial, compliance, surface and coal ownership information, surface water hydrology, surface water management, transportation facilities, post-mining land use and revegetation, wetlands, reclamation plans and schedules, and other operations plans.


Due to the COVID-19 pandemic, copies of the revision application will not be available for inspection at the Public Service Commission, State Capitol, Bismarck, ND or the McLean County Auditor's Office, County Courthouse, Washburn, ND. You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by June 1, 2020.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
