NOTICE OF RECEIPT OF PERMIT TRANSFER APPLICATION

Westmoreland Beulah Mining, LLC has filed an application to obtain Surface Coal Mining Permit KRSB-8802 from Dakota Westmoreland Corporation. This permit covers lands located in:

**All or portions of Sections 7, 8, 17, 18, 19, and 20 of T143N, R87W, Oliver County; and, Sections 10, 11, 12, 13, 14, 15, and 24 of T143N, R88W, Mercer County, containing 4,905.9 acres.**


The application proposes to transfer the existing permit from the current permittee, Dakota Westmoreland Corporation, to Westmoreland Beulah Mining, LLC. Westmoreland Beulah Mining, LLC. will be both the permittee and operator for this permit at the Beulah Mine and will assume all the regulatory obligations previously held by Dakota Westmoreland Corporation.


The transfer application and current surface coal mining and reclamation permit may be inspected at the Office of the Director, Reclamation Division, Public Service Commission, 600 East Boulevard Avenue, Dept. 408, Bismarck, North Dakota and the Office of the County Auditor, Mercer County, Stanton, North Dakota and the Office of Oliver County Auditor, Oliver County, Center, North Dakota. You may submit written comments or objections on the proposed permit transfer application and its effects on the environment and on surface owners of the land in the permit area.
