### NOTICE OF RECEIPT OF REVISION APPLICATION

July 23, 2020

The Falkirk Mining Company has filed a revision application to Surface Mining Permit NAFK-9503 that proposes to revise the post-mining topography for a large portion of the unmined areas within the permit and changes the mining schedule for the S1/2 of Section 2 and the SE1/4 of Section 3, T144N, R84W to begin in 2021. Updates are provided for introductory, legal, financial, compliance, surface and coal ownership information, surface water hydrology, surface water management, operations plans, existing structures, transportation facilities, reclamation plans and schedules, post-mining land use and revegetation and wetlands sections. The stand-alone Consolidated Bonding sections have also been updated with the revision.

Due to the COVID-19 pandemic, copies of the revision application will not be available for inspection at the Public Service Commission, State Capitol, Bismarck, ND or the McLean County Auditor's Office, County Courthouse, Washburn, ND. 
You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by September 14, 2020.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.


