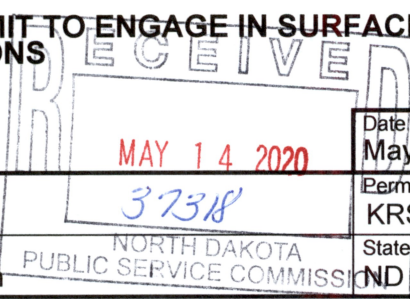

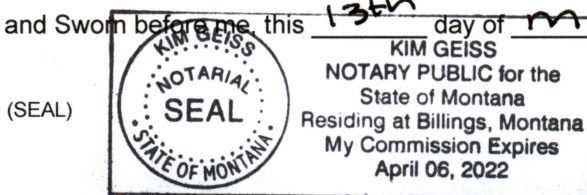

## **Renewal Request Narrative**

Coal removal has been completed from the permit area. Renewal number 6 will allow for the final reclamation of portions of the permit area to be completed during the five-year period commencing October 23, 2020.

## **Surface Coal Mining and Reclamation Bond Narrative**

Surface coal mining bond 64S103557522 for permit KRSB-8802 is issued on a continuous basis and shall maintained and remain in full force and effect during the ensuing five-year renewal term, in accordance with the provisions of Section 38-14.1-16 of the North Dakota Century Code. The bond amount is sufficient to perform the required work for the worst-case reclamation condition in the permit area.

**NOTICE OF RECEIPT OF RENEWAL APPLICATION**

Dakota Westmoreland Corporation has filed an application for Renewal No. 6 to Surface Coal Mining Permit No. KRSB-8802 at the Beulah Mine covering lands located in:

**All or portions of Sections 7, 8, 17, 18, 19, and 20 of T143N, R87W, Oliver County; and, Sections 10, 11, 12, 13, 14, 15, and 24 of T143N, R88W, Mercer County, containing 4,905.9 acres.**

The five-year permit renewal will allow Dakota Westmoreland Corporation to continue operating under approved operation and reclamation plans until October 23, 2025. All coal has been removed from the permit area. The permit area east of ND Highway 49 is in reclamation status, but the permit area west of ND Highway 49 contains long-term facilities, haul roads, stockpiles, and sedimentation ponds used to support mining in another Beulah Mine permit area.

Due to the COVID-19 pandemic, a copy of the permit renewal application will not be available for inspection at the Public Service Commission, State Capitol, Bismarck, ND, or the Mercer or Oliver County Auditor's offices. You may submit written comments or objections regarding the proposed permit renewal application and its effect on the environment and on surface owners of land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal application. The reasons for requesting an informal

conference must be stated in the request. Written comments, objections, or requests for an informal conference must be made by **September 14, 2020**.

If there is an informal conference, you may request a formal administrative hearing on the Commission's ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
