

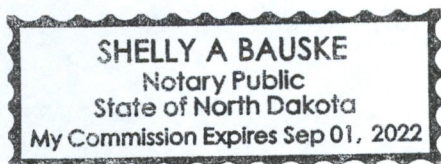

NOTICE OF OPPORTUNITY FOR HEARING

August 26, 2020

On **August 14, 2020**, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Cody Beach at a location in Benson County, ND.

Submitted with the application was a statement by Cody Beach that he desires electric service to be provided by the applicant. Service is to be provided at a point located in:

**The NW 1/4 of Section 27, Twp 143N, R 62W, Stutsman County,
North Dakota.**

Otter Tail Power Company has made a prima facie showing that it should serve the customer.

Any interested party has the right to file written objection, based on the issue of public convenience and necessity, with the Commission by **September 21, 2020** and the matter will then be set for hearing. If no objections are received by that date, the application may be granted as requested.
