Leonardite Products LLC has filed applications to revise and renew Surface Coal Mining Permit No. GRGR-0501 covering land located in:

**A portion of the W $\frac{1}{2}$  of Section 8 of T154N, R100W, Williams County containing 96 acres.**

The five-year permit renewal will allow Leonardite Products LLC to continue operating within the existing permit area until November 2, 2025. The revision application identifies the next five-year commercial leonardite removal subarea and updates the operation and reclamation plans, and the worst case bond estimate, for the next permit term.

Due to the COVID-19 pandemic, a copy of the permit revision and renewal applications will not be available for inspection at the Public Service Commission, State Capitol, Bismarck, ND, or the Williams County Auditor's office. You may submit written comments or objections regarding the proposed permit revision and renewal applications, and their effects on the environment and on surface owners of land in the permit area. You may request an informal conference with the Commission and the applicant on the revision and renewal applications. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for an informal conference must be made by **September 11, 2020**.
