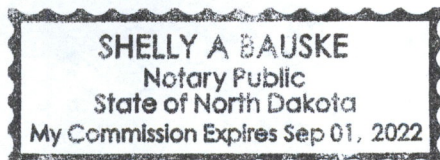

CORRECTED ORDER

September 23, 2020

On September 9, 2020 the Commission issued an Order that incorrectly referenced Wilton Wind Energy I, LLC as Wilton Wind Energy 1, LLC. This September 23, 2020 reissuance corrects that error.

On August 10, 2005, in Case No. PU-05-205, the Commission issued Corridor Certificate No. 88 and Route Permit No. 98 to FPL Energy Burleigh County Wind, LLC for construction of collector substation facilities associated with approximately 4.4 miles of 230 kV electric transmission line in Burleigh County, ND.

On July 1, 2020, FPL Energy Burleigh County Wind, LLC and Wilton Wind Energy I, LLC filed a joint application for transfer of Corridor Certificate No. 88 and Route Permit No. 98 from FPL Energy Burleigh County Wind, LLC to Wilton Wind Energy I, LLC.

On July 23, 2020, the Commission issued a Notice of Opportunity for hearing that provided until August 31, 2020 for receiving written comments and hearing requests. No response was received. The notice identified the issues to be considered in this matter:

1. Whether Wilton Wind Energy I, LLC agrees and is able to comply with the terms and conditions of Corridor Certificate Number 88 and Route Permit Number 98, and
2. Whether the requested transfers are compatible with the public interest.

Wilton Wind Energy I, LLC is foreign limited liability company authorized to do business in North Dakota with a principal address of 700 Universe Blvd, Juno Beach, FL, 33408.

FPL Energy Burleigh County Wind, LLC and Wilton Wind Energy I, LLC. are both indirect, wholly owned subsidiaries of NextEra Energy Resources, LLC, which is a wholly-owned indirect subsidiary of NextEra Energy, Inc.

The Affidavit of Lane S. Witten, Assistant Vice President of FPL Energy Burleigh County Wind, LLC and Wilton Wind Energy I, LLC, states that Wilton Wind Energy I, LLC has the financial and technical qualifications and other backing from NextEra Energy Resources to own and operate the substation facilities. Further, Wilton Wind Energy I, LLC agrees to assume the rights and obligations of Certificate of Corridor Compatibility Number 88 and Route Permit Number 98, and agrees to comply with the terms and conditions set

forth in Certificate of Corridor Compatibility Number 88 and Route Permit Number 98 and all applicable Commission orders pertaining to Certificate of Corridor Compatibility Number 88 and Route Permit Number 98.

Having considered this matter, the Commission finds Wilton Wind Energy I, LLC agrees and is able to comply with the terms and conditions of Corridor Certificate Number 88 and Route Permit Number 98 and the requested transfer is compatible with the public interest.

Therefore, the Commission issues its:

Order

The Commission orders:

1. The joint application of FPL Energy Burleigh County Wind, LLC and Wilton Wind Energy I, LLC. for transfer of Certificate of Corridor Compatibility Number 88 and Route Permit Number 98 is APPROVED.
2. First Reissued Certificate of Corridor Compatibility Number 88 is issued to Wilton Wind Energy I, LLC.
3. First Reissued Route Permit Number 98 is issued to Wilton Wind Energy I, LLC.




A transmission facility collection substation site consisting of approximately 17 acres in the SE ¼ of the SE ¼ of Section 17, T142N, R79W.
