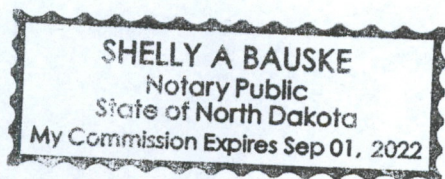


Submitted with the application was a statement by Scott Chase that he desires electric service to be provided by the applicant. Service is to be provided at a point located in:

R 65W, Benson County, North Dakota.**


Otter Tail Power Company has made a prima facie showing that it should serve the customer.
