This charge is a pass-through of third-party (CenturyLink) cost increases Allstream has incurred due to the FCC's deregulation of analog services. Impacted customers will be provided 30 days' notice in the July billing cycle:

Effective with the August bill cycle, resale business lines and select features may have an additional charge. This charge is a direct pass-through of third party cost increases Allstream has incurred due to FCC deregulation of analog services.
