Dear Mr. Sanderson:

On November 9, 2020, the North Dakota Public Service Commission moved to assess a filing fee of \$70,000 and issue a Notice of Hearing in Nodak Electric Cooperative, Inc., vs. Otter Tail Power Company, Case No. PU-20-356.

On December 3, 2020, Otter Tail Power Company (Otter Tail) submitted a check for \$70,000 but provided its basis for disagreement with the filing fee and reserved a right to challenge imposition of the filing fee and payment.

Based upon Nodak Electric Power Company's (Nodak) December 28, 2020 Response to Otter Tail's Motion to Dismiss and the subsequent revision of issues for the March 3, 2021 Formal Hearing, you will find the submitted check enclosed.

Please note that the fee remains assessed. In the event that Case No. PU-20-356 proceeds differently, the Commission may require Otter Tail to again provide the sum.
