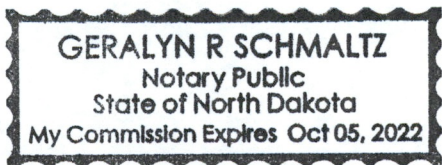

**ORDER REVOKING AUCTION CLERK LICENSE**

**August 26, 2020**

Wayne Fonder, Sisseton, South Dakota, holds auction clerk license number 675 issued by the Public Service Commission under the provisions of N.D.C.C. ch. 51-05.1.

On June 11, 2020, the Commission was notified that the bond issued to Wayne Fonder would be cancelled effective August 14, 2020. N.D.C.C. ch. 51-05.1 requires that an auction clerk maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed, and auction clerk license number 675 issued to Wayne Fonder is revoked.

**Order**

The Commission orders that:

1. Auction clerk license number 675 issued to Wayne Fonder is revoked effective August 14, 2020,
2. Wayne Fonder can no longer clerk at public auction under auction clerk license number 675, and
3. Auction clerk license number 675 shall be surrendered to the Commission immediately.
