This is made to amend contract # PU-849-21-EE (Contract) between the State of North Dakota, acting through its North Dakota Public Service Commission, Public Utilities Division (STATE) and Short Elliott Hendrickson Inc. (CONTRACTOR).

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

The parties agree to amend the Contract as follows:

Extension: Contract section 3 "Term of Contract", "The Contract begins upon execution by both parties and ends on December 31, 2023."

Contract section 3, "Extension Option", "STATE reserves the right to extend the Contract up to two times for an additional period not to exceed 12 months per extension."

The parties agree to extend the Contract for an additional twelve months; therefore, the Contract is amended to change the expiration date to December 31, 2024. The Contract may be extended in the future two additional times up to 12 months each.

All other terms of the Contract remain in effect.

This Contract Amendment is not effective until fully executed by all parties.
