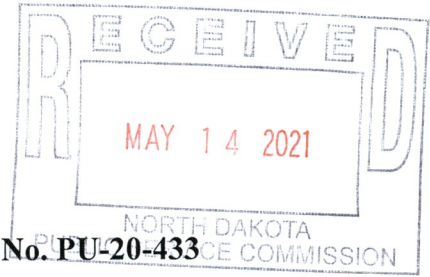

**ORDER GRANTING ADMISSION PRO HAC VICE**

On May 6, 2021, Zeivel T. Simpser, Dorsey & Whitney, LLP, Minneapolis, Minnesota, filed a Motion for Admission *Pro Hac Vice*, and Affidavit of Matthew B. Harris, Lead Assistant General Counsel, Exel Energy Services Inc., Minneapolis, Minnesota. 
