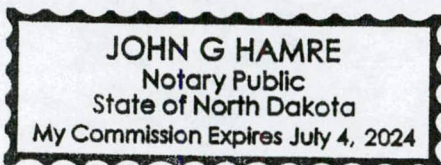

ORDER REVOKING AUCTIONEER LICENSE

November 9, 2020

Kenneth F. Richter, Jr., Drake, North Dakota, holds auctioneer license number 972 issued by the Public Service Commission under the provisions of N.D.C.C. ch. 51-05.1.


On August 28, 2020, the Commission was notified that the bond issued to Kenneth F. Richter, Jr. would be cancelled effective October 23, 2020 or the earliest time permitted under the terms of the bond and/or statutes covering this bond. The earliest time permitted is October 28, 2020. N.D.C.C. ch. 51-05.1 requires that an auctioneer maintain adequate bond coverage and provides that the Commission, without hearing, shall revoke the license effective the date the bond is cancelled unless a new bond is filed or notice to reinstate the cancelled bond is received. No bond or reinstatement was filed, and auctioneer license number 972 issued to Kenneth F. Richter, Jr. is revoked.

Order

The Commission orders that:

1. Auctioneer license number 972 issued to Kenneth F. Richter, Jr. is revoked effective October 28, 2020,
2. Kenneth F. Richter, Jr. can no longer cry at public auction under auctioneer license number 972, and
3. Auctioneer license number 972 shall be surrendered to the Commission immediately.


