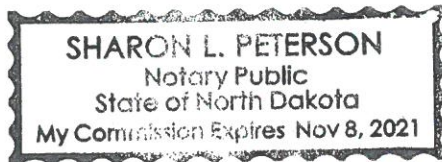

Biden aides working to fight 'lame duck' label

WASHINGTON — When he takes the presidential oath of office in January at the age of 78, Joe Biden will be the oldest person to hold the office. Fighting off the debilitating “lame-duck” label is already on his advisers’ to-do list.

As they work to fill White House staff and Cabinet posts and strategize about the new administration’s agenda, top advisers are also trying to figure out how to lay down a marker that Biden, who has portrayed himself as a transitional, stabilizing figure — a bridge to the next generation of Democratic leaders — has not ruled out running for a second term as he approaches 82, according to a source familiar with the transition team’s conversations.

The prospect of Biden serving just a single term will remain a matter of speculation no matter what he says. But the Biden circle’s determination to tamp down the chatter reflects an awareness that such talk could hinder his effectiveness in an already challenging situation, one in which he faces dual economic and public health crises without party majorities in Congress to pass an ambitious response.

Perhaps most of all, unchecked speculation that Biden won’t run again would only encourage divisive jockeying to succeed him among Democratic presidential hopefuls waiting in the wings — from his own vice president, Kamala Harris, to prospective Cabinet secretaries, members of Congress and state leaders.

“It’s a much bigger problem for him within the Democratic Party,” said Alex Conant, a Republican

operative and veteran of Florida Sen. Marco Rubio’s 2016 presidential campaign. “To the extent there’s Democrats on the day he’s sworn in angling to be the nominee four years later, that creates a difficult situation for him. Republicans are running for president in 2024 regardless.”

Biden’s confidants — incoming White House chief of staff Ron Klain and senior counselor Steve Ricchetti, along with Anita Dunn, who will be an outside adviser — share that view and are determining how best to preemptively defuse a potentially destabilizing situation within the Biden administration and the Democratic Party. Any perceived daylight between the new president and Harris, or between them and essential

party allies such as Massachusetts Sen. Elizabeth Warren, could be magnified by the media into the first skirmishes of a 2024 presidential primary battle.

A Biden transition spokesman pointed to the president-elect’s past comments during the Democratic presidential nomination race, when he said on multiple occasions that he “absolutely” was not ruling out seeking a second term.

Of course, the fact that Biden’s early window to drive his policy agenda is likely a small one is only partly a function of his age.

The bigger challenges are the crises he inherits, his party’s narrow margins in both the Democratic-led House and a Senate where Republicans are likely to maintain a majority, and the likelihood that Trump will try to sabotage him constantly from the sidelines, breaking yet another norm — that former presidents fade into retirement and remain mostly mute about their successors’ actions.

Yet the perception of Biden as a lame duck would only add to his trials, encouraging factions when party unity is essential.

“He’s inheriting the worst crisis since FDR and the Great Depression, but he has a much weaker hand than Roosevelt with the Senate in the hands of the other party, the Democratic House majority reduced and Trump refusing to leave the stage,” said David Gergen, who has served as a counselor to presidents of both parties. “It’s going to be very difficult to govern and get big things done. It’s really important that in first 100 days or more that President-elect Biden undersells and overdelivers.”

In the weeks leading up to Election Day, Biden’s top

aides conferred with Democrats on Capitol Hill about an ambitious agenda, including discussions of doing away with the Senate filibuster and a package to combat climate change. They hadn’t planned, however, for Republicans to keep control of the Senate, which will be the case unless Democrats defy the odds and sweep both runoff elections in Georgia on Jan. 5.

The first 100 days of a presidency, historically a new executive’s best opportunity to capitalize on post-election momentum and good feelings, are likely to be especially critical for Biden under the circumstances.

Ronald Reagan, who at 69 in 1981 was the oldest president to take office to that point, allayed much of the anxiety about his age and stamina by empowering his Cabinet and his first chief of staff, James A. Baker III. Reagan’s example offers something of a template for Biden, according to John A. Farrell, a presidential historian.

When Reagan was shot just two months after taking office, “People didn’t know if he was going to seek a second term,” Farrell said. “And he was easily reelected.”

Mack McLarty, who served as President Bill Clinton’s first chief of staff, said that if Biden can begin his presidency by fostering bipartisan collaboration on economic relief and oversee a successful distribution of COVID-19 vaccines, he could build a foundation for other legislative compromises down the road.

[1] NOTICE IS HEREBY GIVEN that a hearing will be held on a Petition for Appointment of Guardian for Joan Laurel Murphy Willett, an Incapacitated Person, which is filed in the office of the Clerk of this Court, in the County Courtroom of the Stark County Courthouse, Dickinson, North Dakota, on the 23rd day of December, 2020, at 2:00 o'clock p.m., Mountain Time, before a District Judge.

[2] This hearing will be to determine whether a guardian should be appointed for you. If it is in your best interests, the hearing may be held some place other than the courthouse.

[3] A Petition is on file with the Clerk of Court that explains why someone is asking to be appointed your guardian. You can review it before the hearing or at the hearing. Some of your rights may be affected by having a guardian appointed for you. Some rights that may be affected include your right to vote, to refuse prescribed medications, obtain or retain a driver's license, seek to change marital status, or possess a firearm.

[4] You MUST attend this hearing unless excused by the Court.
[5] You may be assisted by the guardian ad litem appointed by the Court. The guardian ad litem is an attorney appointed to advocate for your best interests and to explain what may happen as a result of the hearing.
[6] You may hire an attorney to represent you and present your point of view about whether a guardian should be appointed.
[7] The Court has also appointed an expert examiner to examine you and has appointed a visitor to interview you and the proposed guardian.
[8] Other people who are interested parties have a right to respond or object to the Petition to appoint a guardian for you. Interested parties may hire an attorney to represent them at the hearing.
[9] You, the person who filed the Petition, and others who are permitted to participate in the hearing have the right to present evidence and to call and ask questions of witnesses, which may include the court-appointed expert examiner and court-appointed visitor.
[10] A Judicial Referee may decide whether you are in need of a guardian. You have the right to have your case decided by a Judge of the District Court, instead of a Judicial Referee. If you want a Judge of the District Court to decide whether you are in need of a guardian, you must file a written request with the Clerk of this Court within seven (7) days after receiving this Notice of Hearing and Statement of Rights.

[11] If the Court finds that you are in need of a guardian, the Court will consider whether the person proposed to be your guardian should be appointed. The Court will also consider whether some other qualified person should be appointed as your guardian. The Court will also determine whether there should be any limits on the powers and duties of the guardian so that you keep control over certain activities.

JRMC purchases second COVID-19 fighting robot

Public asked to name it

Jamestown Regional Medical Center has purchased its second Xenex LightStrike germ-zapping robot and is asking the public to help name it.

In 2018, the community helped pay for the first robot by donating \$100,000 as part of the Giving Hearts Day fundraiser.

"As a thank you, we asked for the community's help to name her," said Lisa Jackson, JRMC Foundation director. "The result was 'R.O.S.I.E.," which stands for 'Robot Offering Safe Ideal Environment.'"

Bacteria and other germs are naturally found everywhere. Despite efforts to disinfect, superbugs like COVID, MRSA and C.diff are resistant to chemicals and common cleaning practices.

Each year, drug-resistant bacteria infect more than 2 million people nationwide and kill 23,000, according to the Centers for Disease Control and Prevention. More than 1,800 North Dakotans have

been hospitalized due to COVID-19 since March.

That is one of many reasons why JRMC invests in ways to enhance patient care and safety.

The robot pulses environmentally-friendly xenon ultraviolet (UV) light and destroys microscopic bacteria, viruses or other microorganisms. It is 99.9% effective in enhancing environmental cleanliness by destroying hard-to-kill superbugs in hard-to-clean places.

The use of R.O.S.I.E. has increased dramatically since the opening of the JRMC Cancer Center, the expansion of specialty care and because of the pandemic.

"Everyone that comes into the hospital - patients, families, staff - brings germs with them," said Dane Grebel, JRMC environmental services manager. "Some of these germs are resistant to even the best cleaning solutions and methods available. That is why JRMC invested in this technology. We want the best

and safest place for our patients to receive care. R.O.S.I.E. and our second robot gives patients assurance that we are safer and cleaner."

JRMC purchased R.O.S.I.E. long before COVID-19; however, she

needs help.

"Our environmental services and nursing crews use R.O.S.I.E. in every patient room at least twice between each patient," Grebel said.

Following manual cleaning, R.O.S.I.E.

can disinfect a typical patient or procedure room with its UV light in 10-15 minutes. R.O.S.I.E. is a tool for the hospital but does not replace any person or position at JRMC. The second robot will allow teams to clean

more rooms faster.

Speed is important as COVID-19 continues to spread throughout the community.

To celebrate the new Xenex robot to help R.O.S.I.E., JRMC asks children and adults to participate in a Name-The-Robot contest. More than 200 children from Jamestown and rural schools submitted coloring pages and suggestions for names in 2018. JRMC hopes they'll do the same this year.

The Name-The-Robot contest is open through Dec. 4. Submit an entry at www.jrmcnd.com/name-that-robot.

The second robot is one example of JRMC offering the most up-to-date equipment in the region, said Mike Delfs, JRMC president and CEO.

Quarter of North Dakotans Know Someone Who Has Died of COVID-19

By John Hageman ND Newspaper Association A new poll shows nearly one in four North Dakotans know someone who has died from complications of COVID-19, a stark indicator of the pandemic's ongoing devastation in this sparsely populated state.

Meanwhile, more than three-fourths of respondents from the conservative and Republican-led state support some form of mandates to curb the spread of the coronavirus.

The poll was commissioned by the North Dakota Newspaper Association, and responses were gathered online by Nashville, Tenn.-based Coda Ventures from Nov. 4-16. Pollsters questioned 400 North Dakotans from across the state on their attitudes about wearing masks in public, the government's response to the pandemic and how they've been affected by the public health crisis.

There was already plenty of evidence of the pandemic's growing destruction in North Dakota. More than 1 in 1,000 North Dakotans have died from COVID-19 and more than 75,000 have tested positive, straining the state's health care system.

But the North Dakota Newspaper Association poll adds more context to the pandemic's scale.

Nearly half of the poll's respondents reported that they or someone they know has tested positive for COVID-19, and 24 percent said they knew someone who lost their life because they contracted it.

The poll, which was done in partnership with the education and public workers union North Dakota United, also tallied the economic damage left by the pandemic. A third of the respondents said they had seen a reduction in their paycheck, hours or sales. Another 15 percent had been furloughed, laid-off or otherwise lost their job.

And though 83 percent of respondents agreed that wearing masks, social distancing and avoiding crowds is the best way to stop the virus, only 67 percent said they "always" wear a mask in public places. In late October, just before polling began, the White House's coronavirus response coordinator said Bismarck residents' adherence to COVID-19 guidelines was the worst she had seen in the country.

Tanis Welch, an associate professor in public health education at the University of North Dakota, said more people are wearing masks now, but their initial aversion to them has forced more drastic choices today.

"Why weren't we talking about these mask mandates in March,

April and May?" she said.

Pollsters gathered most of the responses before North Dakota Gov. Doug Burgum reversed course and issued a statewide mask mandate earlier this month to curb the coronavirus's spread. The order, which is in effect through Dec. 13, also limits bar and restaurant capacity.

Avoiding statewide restrictions by relying on a message of personal responsibility in recent months, the Republican governor said a recent surge in cases required a change.

Despite Burgum's reluctance, the NDNA poll found 60 percent of North Dakotans support a statewide mandatory mask order. That enjoyed less approval than a local government mandate (68 percent support), but it was more popular than a national masking requirement (56 percent support).

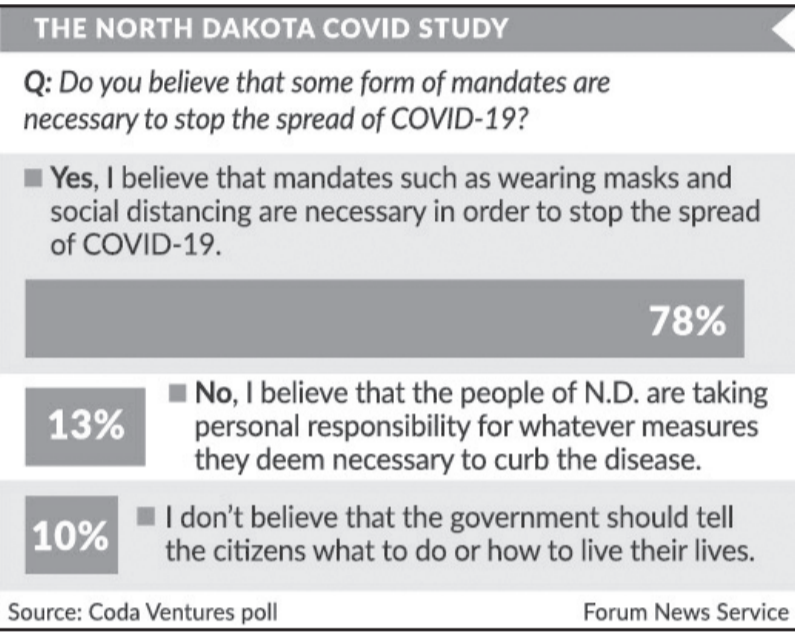
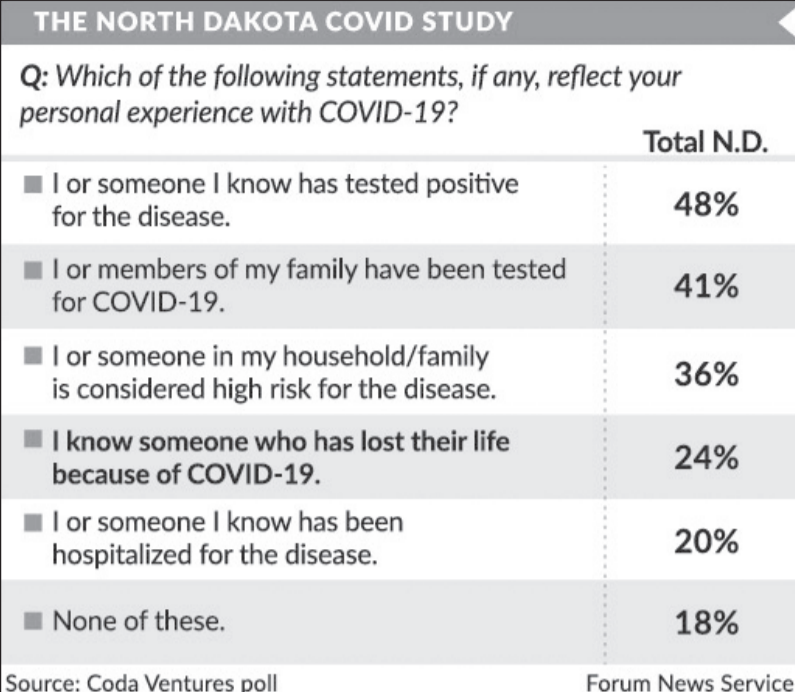
Burgum's spokesman Mike Nowatzki said the governor's decision was based on reduced hospital capacity and "feedback from local leaders and local public health units that enforceable state action would support their local efforts."

"The governor has consistently echoed the recommendations of health experts for increased mask usage and will continue to encourage the use of face coverings to help slow the spread of coronavirus and take pressure off North Dakota's hard-working frontline health care workers," Nowatzki said.

Moreover, 78 percent of poll respondents favored some form of mandates, whether it's social distancing or masking requirements. More than half said businesses like bars, restaurants, entertainment venues, salons and fitness centers should remain open but with capacity limits and social distancing rules.

"Our civic leaders should take a great deal of encouragement that the majority of North Dakotans support these measures," said Dr. Paul Carson, an infectious disease specialist and public health professor at North Dakota State University.

But there have already been signs of resistance to the governor's mandate. Multiple county sheriffs have issued statements saying they won't enforce the mask-



ing order, and the Tioga School Board voted against implementing it before financial pressure from the state caused them to reverse course, said Board President Mark Schmidt.

"We're not not wearing masks. The issue is local control and personal choice," he said. "We don't believe that COVID is fake."

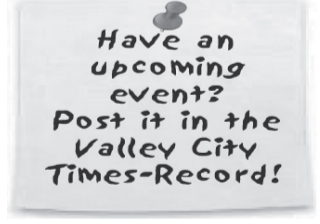
Of the 11 percent of survey respondents who said they only sometimes, rarely or never wear a mask, most either questioned their effectiveness or said requiring a face covering "infringes on my freedom of choice."

The Centers for Disease Control and Prevention says masks are effective in blocking respiratory particles that spread COVID-19, and it recommends people wear non-valved, multi-layer cloth masks. The federal agency says that's especially important for people who are unknowingly infected with the virus but aren't showing any symptoms.

Carson raised concerns about the state's rate of mask usage as well as the 14 percent of respondents who said they continue to socialize in public places without social distancing, a practice that he said contributes to the virus's spread.

The survey was completed just before the Thanksgiving holiday, which health officials worried would fuel the continued spread of the virus as people gathered with friends and family.

"It's a really critical time coming up with the holidays," said Rena Moch, public health director for the city of Bismarck and Burleigh County. "If we continue to go down the path that we are, the Christmas holiday could be much worse than what we're experiencing right now."

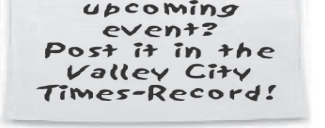
