It is clearly in MEC service territory but had come to a one-time agreement that it would be advantageous for the ND DOT, cost wise to have it served by OTC. Similar to previous agreements between MEC and OTC, OTC would service the load but provide an agreed upon formula, which is \$1200.00. to date, OTC has not fulfilled the agreement with MEC, so we will be protesting temporary authority for this project.
