NOTICE OF RECEIPT OF REVISION APPLICATION

May 5, 2021

The Coyote Creek Mining Company, L.L.C. has filed an application for Revision No. 11 to Surface Coal Mining Permit No. NACC-1302 for the Coyote Creek Mine. This revision adds plans to mine the SE1/4 of Section 23, T143N, R89W as well as two federal coal tracts located in the SW1/4 of Section 24 and SE1/4 of Section 26, T143N, R89W. The federal coal lease for these two tracts was obtained by Coyote Creek Mine in the 4th quarter of 2020.

Copies of the revision application are available for public inspection at the offices of the North Dakota Public Service Commission, 600 East Boulevard Ave., Bismarck, ND 58505-0480 and at the office of the County Auditor, Mercer County Courthouse, PO Box 39, Stanton, North Dakota 58571. A DVD copy of the revision application may also be requested by contacting the Public Service Commission at 701-328-2400 (877-245-6685 toll free) or ndpsc@nd.gov, or by sending a written request to the Public Service Commission, at the address above.

You may submit written comments or objections on the proposed permit revision application and its effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the revision application. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by **June 21, 2021**.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
