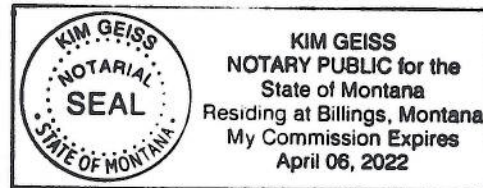

Allegation: Failure to comply with ARM 17.24.646(1) and 17.24.304.

Abatement: Update MQAP, monthly download commitment.

Issued: By North Dakota Public Service Commission on July 3, 2018 to Dakota Westmoreland Corporation by certified mail.

Allegation: Dakota Westmoreland Corporation violated North Dakota Century Code Subsection 38-14.1-07(5) - Surface coal mining operations are prohibited within one hundred feet [30.48 meters] of a cemetery. The violation was observed during a routine inspection of the Beulah Mine on June 27, 2018 and the distance between the topsoil stripping edge and the cemetery fence was measured with a steel tape and Real Time Kinetic Global Positioning System during a follow-up inspection on June 29, 2018.

Abatement Action: Topsoil has been respread on the affected area and seeded. The 100-foot buffer zone on the north side of Emmaus Cemetery has been clearly marked. All activities have been complete within the abatement time of 15 days.

Fine Assessed: \$1,500.00

Termination: August 22, 2018

North Dakota, Beulah Mine, Permit KRSB-8603

Issued: By North Dakota Public Service Commission on July 18, 2019 to Dakota Westmoreland Corporation by certified mail.

Allegation: Uncontrolled discharge from Pond P85 exceeded the maximum total suspended solids allowed by the North Dakota Pollution Discharge Elimination System (NDPDES) Permit. The total suspended solids (TSS) of the discharge was 225 mg/L and the maximum TSS allowed by the NDPDES permit is 70 mg/L. In addition, uncontrolled discharge was caused by failure to provide adequate storage in Pond P85 and associated sump to control a 10-year 24-hour precipitation event.

Abatement Action: A sump upstream of Pond 85 has been built to re-establish adequate storage capacity for that area. A letter informing the uncontrolled discharge above maximum TSS level has been sent out to the corresponding agencies.

Fine Assessed: \$1,500

Allegation: Failure to comply with ARM 17.24.702(2).

Abatement: (a) Immediately cease all mining activities within 500 feet of Soil Storage Area B-36, as delineated on the 2018 Annual Report Field Map, until abatement actions under (b) are completed.
(b) Remove all remaining soil from stockpile B-36, and all disturbed materials determined suitable and transport it to an approved stockpile location,
(c) Submit a minor revision including procedures to prevent stockpiles located ahead of mining and within the area of disturbance (e.g. Stockpiles B-34, B-1, B-2) from being similarly disturbed. These procedures should include specific setbacks and timelines for mining activities occurring near soil stockpiles.

Penalty: \$3,575

Allegation: Failure to protect a cultural resource site. Site LA 187597 was disturbed by a temporary road constructed prior to mitigation. Specifically, Mitigation Procedures –Existing Sites #1, Page 801-7, Permit 2014-01.

Abatement: (a) Complete blocking of exploratory road with berm at main entrance point.
(b) Reclaim road and drill pad site (with archaeological monitor per BLM Stipulations).

Penalty: \$250
