

NOTICE OF OPPORTUNITY FOR HEARING

May 5, 2021

On **April 8, 2021**, Otter Tail Power Company, an electric public utility, filed an application under North Dakota Century Code Chapter 49-03 to extend service to Brady and Danielle Buchanan at a location in Stutsman County, ND.

Submitted with the application was a statement by Brady and Danielle Buchanan that they desire electric service to be provided by the applicant. Service is to be provided at a point located in:

**The SW 1/4 of Section 35, Twp 139N, R 64W, Stutsman County,
North Dakota.**

Otter Tail Power Company has made a prima facie showing that it should serve the customer.
