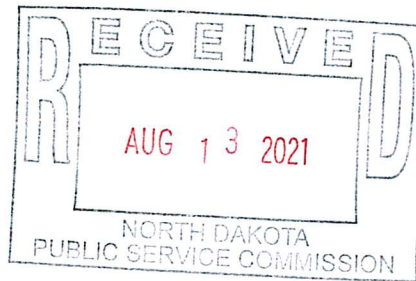

1. Please revise page 1 of the application form to list the permit acreage being deleted with Revision No. 34 and add a revised application date header on page 1. Coteau's permit acreage calculation is not in question but the permit acreage remaining in the Commission's records (1,155.3680) must be entered on the application form to delete the permit acreage. Please also revise Attachment 1 to describe deleting 1,155.3680 acres. (WTG/JAR)

Page 1 of the application form and page 1 of Section A-1 have been revised as requested.

2. Please revise Attachment 1 to add the metes and bounds description for the deletion area listed on Section A-2 (Area to be Deleted from Permit NACT-8203 Map). A metes and bounds description for the deletion area is required for our revision approval award form. (WTG/JAR)

Pages 1 and 3 of Section A-1 have been revised as requested.


