DECLARATION OF FIRE EMER-**GENCY AND BURN BAN** for SLOPE COUNTY

(Effective 04/07/2021) WHEREAS, Slope County, North Dakota has and is currently enduring dry conditions, has a large volume of

dry vegetation, and

WHEREAS, Slope County has committed all available resources to protecting life and the property of its cit-

WHEREAS, the impact of fires would threaten the health, wellbeing, and safety of the citizens of Slope County, and

WHEREAS, the cost of such fires may exceed the resources of Slope

We are very pleased to provide you with this year's Annual Drinking Water Quality Report. We want to keep you informed about the excellent water and services we have delivered to you over the past year. Our goal is to provide ou with a safe and dependable supply of drinking water. Our water source is from the Foxhill and Hell Creek Aquifer We have five (5) wells with depths from 1050'to 1150'.

Community water systems are required to fully inform citizens about the source and quality of their drinking water, nowever, events since September 11, 2001 also required that disclosure of public information does security of water systems.

The City of Bowman is participating in North Dakota's Wellhead Protection Program. Copies of the Wellhead Protection Program plan and other relevant information regarding this program can be obtained from the City Auditor during normal office hours.

Our public water system, in cooperation with the North Dakota Department of Environmental Quality, has completed the delineation and contaminant/land use inventory elements of the North Dakota Source Water Protection Program. Based on the information from these elements, the ND Department of Environmental Quality has determined that our source water is not likely susceptible to potential contaminants.

"I'm pleased to report that our drinking water is safe and meets federal and state requirements", said Bill Mason, Water Superintendent.

This report shows our water quality and what it means. The City of Bowman would be appreciative if large volume water customers would please post copies of this Annual Drinking Water Quality Report in conspicuous locations or distribute them to tenants, residents, patients, students, and/or employees, so individuals who consume the water, but do not receive a water bill can learn about our water system. We will make a "Good Faith" effort for this report to be available to all residents.

The City of Bowman routinely monitors for contaminants in your drinking water according to Federal and State laws. The following table shows the results of our monitoring for the period of January 1 st to December 31', 2020 . As authorized and approved by EPA, the state has reduced monitoring requirements for certain contaminants to less often than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of our data, though representative, is more than one year old.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land, or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants That May Be Present in Source Water:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also, come from gas stations, urban stormwater runoff and septic systems.
