



Adoption of Bowman County Zoning Ordinance

The Bowman County Commission adopted a new zoning ordinance on August 3, 2021.

This ordinance will take effect thirty (30) days from the date of the first publication of this notice and will replace the existing county zoning ordinance. A copy of the adopted ordinance is available for inspection at the office of the Bowman County Auditor, 104 1st Street NW, Bowman, ND, between the hours of 7:30 am and 12 Noon and 12:30 to 4:30 pm

Monday - Thursday. 7:30 am to 12 Noon on Friday.

The ordinance states that shooting ranges may be conditionally permitted in Agriculture Districts, Commercial Districts, and Industrial Districts, provides a definition of shooting ranges, and removes language requiring shooting ranges be established for 3 years from the wind ordinance and solar ordinance.

Pursuant to the provisions of the N.D.C.C., Section 11-33-10, any person aggrieved by any provision contained within the adopted zoning ordinance shall have thirty (30) days from the date of the first publication of this notice to file with the Bowman County Auditor a petition to the county commission for a separate hearing regarding the objection.

The petition must be in writing and specifically state the grounds for the objection to the adoption of the whole or any part of the adopted zoning ordinance.
