In accordance with Certification Provision No. 11 of the North Dakota Public Service Commission's ("Commission") Order issuing a Certificate of Site Compatibility for the Bowman Wind Project, Bowman Wind, LLC provides notice of its intent to start construction of the Bowman Wind Project on or about March 25, 2025.<sup>1</sup>

In accordance with Certification Provision No. 3 of the Commission's Order, Bowman Wind, LLC hereby files electronic copies of the following permits:
