Meeting Minutes

Meeting started at 2:00 p.m. central time, with participants attending remotely. After introductions, Mr. Renfandt explained that there are specific requirements contained in the NDPSC Order for Case PU-21-121 and the attached Certification Relating to Order Provisions (Certification). Ms. Smith shared her screen and put the Order and the certification on her screen for all attendees to view these requirements together. Mr. Renfandt then discussed several of these requirements, including tree and shrub mitigation requirements, topsoil removal requirements, monthly reporting obligations, and other reporting requirements. Mr. Renfandt confirmed that monthly construction reports could be suspended between fall and spring construction (with the intent to do so noted in the last fall monthly report). Mr. Renfandt also noted that reports of extraordinary events (see Certification Provision No. 32) should be called out separately, rather than buried in the monthly construction report. Additionally, Mr. Renfandt confirmed that injuries reportable under Certification Provision No. 32 are those reportable pursuant to Occupational Safety and Health Administration (OSHA) requirements. Mr. Wilson explained Bowman Wind's anticipated construction schedule, including limited topsoil/subsoil removal/segregation in early December, limited construction activity in December, then suspending construction activity for the winter and resuming in April of next year. The Bowman Wind team and Mr. Jackson discussed potential timing of and coordination regarding the initial topsoil segregation inspection in early December. The meeting concluded at approximately 2:35 p.m.
